## GLOBAL REBOOKING POLICY CHANGE

15% BONUS ADDED TO EMD VOUCHER OPTION



### **Effective May 15th:**


- Any flight that is cancelled from this date forward, customer has choice of full refund or voucher (USA already, now global)
- If customer chooses voucher option, a 15% bonus is added to incentivize this choice
- Voucher is refundable for cash after 12 months, less 15% bonus





## U.S. SKELETON SCHEDULES AT A GLANCE







JUL & AUG to be loaded in GDS the week of 1st of June.



# AIR FRANCE NETWORK EXPANDS IN JUNE (2/2)

### GLOBAL NETWORK TO/FROM CDG GRADUALLY INCREASES WITH FOCUS ON VFR

AFRICA: 12 destinations restart - BKO, CKY, NKC, NIM, LFW, BZV, FIH, LBV, NSI, DLA, BGF, JIB + current COO, ABJ & DSS

#### **MEGI**

**BEY**: startup as of 12JUN in 2/7 DoW 5 and 7 with no MEA exchange then 3/7 DoW 4 6 7 as of 5JUL with balanced exchange on 7/7 P3/P3 flight by ME. AF day schedule as usual. P to be withdrawn in order to allocate a smaller aircraft.

CAI: Startup in 1/7 as of 28MAY on DoW 4 with flight back 24h later. Schedule as usual to well connect NATL.

**DXB**: start in 4/7 as of 05JUN with 2/7 for Pax IB on DoW 3 and 6 rotations (4 and 7 from DXB). Schedule as usual to well connect NATL. As soon as possibility opens, OB will be opened for sale as well.

India: we keep the 1/7 IB per destination started a few weeks ago until 5JUL. As of 5JUL, DEL and BLR will go 2/7. As soon as possibility opens, OB will be opened for sale as well. Schedule as usual to well connect NATL.

#### **ASIA**

SIN: 3/7 cargo only destination as of 18MAY. Commercialisation of 1/7 to pax as of 1JUN on DoW 6 (coming back on DoW 3 from SIN)

BKK: 3/7 cargo only destination as of 25MAY. No plans yet to re commercialise to pax

SGN: going 4/7 with additional cargo charter. Plans to open to pax again as of 5JUL in 3/7. VN HAN still expected to restart only as of 1SEP

HKG: currently 3/7 becoming 7/7 as of 1JUN. Plans to open to pax again as of 1JUN 2/7 DoW 1 and 5 (back on 4 and 1 from HKG). July expected at 3/7 for pax

**PVG**: keeping 8/7 cargo together with 5/7 Full Freighter

**PEK**: starting as of 1JUN and going to 7/7 cargo as of mid-June via ICN. Signs showing that AF & KL might be authorised soon to re commercialise some frequencies to mainland China

KIX: currently 3/7 cargo only. To be re-commercialised in 2/7 as of 5JUL

NRT: going 5/7 as of 18MAY. Still only 3/7 open to pax in connection with SB flights (now open both bounds to and from NOU)

ICN: startup in 3/7 confirmed as of 5JUL with 2/7 open to pax. Pending: reopening earlier, mid-June if capacities are available

HND: expected to reopen only when there is business motive demand recovery

**EUROPE: 42 destinations** by end of June

FRANCE: 22 domestic routes by end of June



### KLM RESTARTS EUROPEAN NETWORK

MEDIUM HAUL DESTINATIONS GRADUALLY RESTART FROM MAY 4

- Destinations and frequencies may change weekly depending on local authorities

# **AFKL HEALTH & SAFETY UPDATES**

#### **NEW MEASURES EFFECTIVE MAY 11TH**

- Temperature checks prior to boarding all AF flights
- Masks now required on board for all passengers and crew → New Q&A available.
- Social distancing practiced on ground and on board
  - AF
    - ALL AF flights have 6 seats blocked (back of the cabin) in order to be able to isolate a suspected C19 cases on board
    - ITALY flights: limitation at 66% is implemented until 3rd June
    - FRANCE domestic flights are limited to 70% until mid-June
    - All other flights (EUR and Long Haul) are limited to 75% until end May
  - KLM: currently blocking all aisle seats in Economy/Economy Comfort cabins on all eastbound flights from the USA

## CREDIT CARD CHARGE BACKS REMINDERS

### ADM is NOT sent immediately to a travel agent when a CC chargeback is received

- AF & KL in constant communication with banks & CC companies on ticketing policy updates
- Every CC chargeback is thoroughly reviewed & supporting documentation sent to banks
- ADM sent only after the CC chargeback process has been completed if applicable.
- For unsuccessful disputed chargebacks, AF and KL will carry out a thorough review before issuing a debit memo to a travel agent.
- With chargeback validations, the applicable ticket refund policy is taken into account.

#### When TAs use their own Merchant of Record:

- card transactions are processed through their own acquiring contracts, making TA responsible for the follow-up of all chargebacks.
- For all voluntary cancelations of refundable and non-refundable fares, the AFKL standard chargebacks policy is applied.







### TICKET VALIDITY EXTENSIONS

#### OPTIONS AVAILABLE ON AF057 AND KL074 TICKETS

Ticket validity can be extended, and if a travel agent has a ticket that is expiring:

- ☐ Step 1: keep PNR alive and/or rebook when pax is ready
- ☐ Step 2: reissue/revalidate the original ticket

Note: Please use ATC (automatic ticket changer) and if it doesn't work do a manual calculation.
