# Exchange for Credit Voucher due to COVID-19

Regarding travel advisory due to COVID-19, please be advised the exchange for a credit voucher guideline for contracted U.S ARC agencies (Amadeus User only) as follow:

### Purpose :

 Due to the constantly evolving situation related to COVID-19 and the high volume of refund requests, we highly encourage customers to reuse the value of the ticket for future travel without fee since there would be no penalty waiver for normal flight operation.

Applies for tickets issued : On or before March 25, 2020

Issued On : KE 180 Ticket Stock

Applicable to Travel On : Revenue KE International Ticket (KE 180 Ticket Stock)

- \* Including Non-Refundable ticket
- \* Including KE marketing/OAL operating Codeshare flights

Date of Impacted Travel : No restriction

Flights departing from the U.S.A (except GUM) to all destinations

#### **Voucher & Condition**

 Exchange the ticket for a credit voucher in the amount of the original ticket for the passengers who wish to obtain for future use
