MU/781 ticket Involuntary Refund/Exchange special regulations update

Dear Passengers and Travel Partners:

Due to current COVID-19 situation is still unclear, our flights suspension policy continues in effective. To help all affected passengers re-arrange your already booked/ticketed itinerary during current virus situation, we now announce the MU/781 ticket involuntary Refund/Exchange Policy update as follows

For any the Booked and Ticketed MU/FM flight **on/after 24JAN2020 till on/before 24OCT2020** with MU/781 ticket stock, if it involves either MU/FM's international/China domestic flight cancellation or any ticketed MU/FM flight is still in operation but the Destination country limiting the passenger(s) from entering, such affected ticket can be accepted for either **Involuntary refund** or **Changing to a new/available traveling date (including the necessary/reasonable itinerary change) one-time** within the **original ticket validity** with Refund Penalty/Exchange Fee waived.

For Involuntary Ticket Exchange to a new/available traveling date, the maximum travel range can be **extended to on/before 31DEC2020** with MU/FM operating flight(s).

When applying Involuntary Ticket Exchange, it is allowed a necessary/reasonable one-time itinerary change within the same REGION (defines as: Mainland China; US/Canada but not including Saipan; Europe; Australia/New Zealand; Japan; Korea; S. E. Asia including Saipan; S. Asia; Middle East; HKG/Macau; Taiwan; as same REGION individually), according to our "Involuntary Ticket Exchange regulations" passenger(s) can rebook to new/available traveling date(s)/flight(s) within the same REGION operating by MU/FM with any available booking class (RBD) under the same physical cabin based on the original ticket.

- A. For such Involuntary Ticket Exchange involving necessary/reasonable itinerary change within Mainland China REGION, it is allowed to add an additional segment operating by MU/FM as to properly transport PAX to the original China destination and/or from original China departure.
 - For example: if original ticket was SFO-TAO, it allows to change the itinerary as SFO-PVG-TAO.
- B. If the original ticket involved a TRANSIT point change in China, it can be changed the TRANSIT point in China as to properly transport PAX to the original China destination and/or from original China departure.

 For example: it the original ticket was **SIN-PVG-PEK**, it allows to change the itinerary/transit point as **BKK-KMG-PEK**.
- C. If involved any segment change outside Mainland China REGION, passenger must take care any the addition segment operating by other carrier him/herself.
 - For example: If the original ticket was **PVG-ROM(FCO)**, since said route is suspended, MU allows it to change the itinerary to **PVG-PAR(CDG)** with the above Involuntary Ticket Exchange policy. However, the **additional PAR(CDG)-YY-ROM(FCO)** segment must be handled/purchased by PAX him/herself.

For the above affected ticket refund or exchange, passenger may contact:

The special WAIVER code for subject involuntary ticket refund and exchange is: <u>MUNA07CN</u>. All previous announced COVID-19 related waiver codes will be expired by the end of 31MAY2020 and replaced by this new waiver code. This update notice/policy will be in effective on/after 01JUN2020. The end of subject regulations will be announced later It must be inserted into the [Airline Waiver Code] box and the [Endorsement] box by the ticket issuing agency during ARC/BSP ticket refund/exchange process.

关于调整疫情期间东航国际客票退改签规定的通知

尊敬的旅客及旅游同业

由于境外疫情发展趋势尚不明朗,国际航班"五个一"政策继续执行,为了协助旅客安排疫情期间的出行计划, 现调整东航客票退改签规定如下:

自2020年1月24日(含,以航班承运日期为准)至2020年10月24日(含,以航班承运日期为准)期间,凡涉及东上航国际、地区航班取消或航班未取消但目的地国家限制入境,则相关的东航国际客票,可在客票有效期内按非自愿规定办理退票或改期(包含变更行程),改期范围扩大至2020年12月31日(含)之前东上航实际承运航班。旅客申请变更行程,允许在同一区域内变更行程一次(中国大陆; 美加不含塞班; 欧洲; 澳新; 日本; 韩国; 东南亚含塞班; 南亚; 中东; 港澳地区; 台湾省自视为同一区域),旅客可按非自愿规定在相同物理舱位情况下将原航班变更至同一区域内东上航任何实际承运航班。

- A. 变更行程允许额外赠送一段东上航实际承运的**中国大陆境内航段**至(自)原境内目的地(原境内始发地)。例如原客票旧金山-**青岛**允许变更为旧金山-**浦东-青岛。**
- B. 若原客票为**中转联程客票**,允许免费变更**中国大陆境内中转点**,用于运输旅客至(自)原境内目的地(原境内始发地)。例如原客票是**新加坡-浦东**-北京允许变更为**曼谷-昆明**-北京。
- C. 若涉及**中国大陆以外**区域内航段,旅客必须**自行处理**。例如原客票浦东-**罗马**,由于东航浦东-罗马航班取消,东航负责变更为浦东-巴黎,巴黎-罗马航段由旅客**自行处理。**
- 旅客请通过: 1. 原购票渠道 (如原订位/开票 旅行社、代理点、网站等) 办理上述 免费退票 或 免费更改一次
