## Coronavirus Travel Policy of Air Tahiti Nui, The Americas

Updated and Effective: March 2<sup>nd</sup>, 2020

Dear Valued Partner of Air Tahiti Nui, The Americas:

There are no reported cases of Coronavirus in French Polynesia. However, in an abundance of caution, to ensure the well-being of your clients, our crew members, and to make every effort to keep French Polynesia “Coronavirus-free”, our new travel policy applies as follows.

This health order, directed by the Ministry of Health of French Polynesia, has been implemented and effective as of **MARCH 2<sup>ND</sup>, 2020**, and now supersedes the previous travel policy that Air Tahiti Nui sent on February 20<sup>th</sup>, 2020.

### **FOR ALL PASSENGERS TRAVELING TO FRENCH POLYNESIA:**

Before boarding a flight into French Polynesia, **all passengers** regardless of their nationality and prior travel history must present a medical certificate dated no older than 5 days before travel, certifying their condition of good health, completely free of any signs of viral infection. This policy is enforced regardless of their point of embarkation, with end destination French Polynesia.

In the absence of such a certificate, boarding will be denied. It is required that all passengers take the necessary steps to procure this medical certificate prior to their flight.

In the absence of a signed medical certificate, as an alternative, a nearby 24-Hour Urgent Care facility outside of LAX Airport may be able to provide a signed medical certificate. It is our understanding that most US insurances are accepted at this facility, otherwise a \$165.00 USD charge will be applicable for a consultation and clearance for a travel certificate. For customers electing to seek a certificate, allow at least 5 hours as this facility is not connected to LAX, or the Tom Bradley International Terminal.

Please note that you may be required to provide at check-in or onboard the flight, both to and from the United States and French Polynesia, documentation confirming your address in destination, telephone number(s), and email address. This information may be used by the Ministry of Health in French Polynesia as well as the United States Department of Health and Human Services, Center for Disease Control.
